

OPERATING INSTRUCTIONS FOR THE CRUSADER™ GAS POWERED GENERATOR FOR USE WITH ANY PROACTIVE ENVIRONMENTAL PRODUCTS® INTERNATIONAL LLC THAT UTILIZES 12 VOLT DC TECHNOLOGY

Congratulations on purchasing Proactive Environmental Products® International LLC CRUSADER™ Gas Powered Generator (Item # GP-11000)!

PLEASE READ THIS MANUAL BEFORE HOOKING UP THE PUMP OR CONTROLLER!

- HANDLING WARNING: Battery terminals are manufactured from lead, a chemical known to the State of California to cause cancer and birth defects or other reproductive harm. PLEASE WEAR GLOVES WHEN HANDLING battery terminals!!
- Please note: <u>Never leave the Crusader™ alternator "ON/OFF" switch in the "ON" position without the engine running at less than half throttle. Doing so may damage alternator. This is NOT covered under warranty.</u>
- Contains sealed, non-spillable lead acid battery. Must be disposed/recycled properly.
- Possible explosion hazard. Contact with battery acid may cause severe burns and blindness. Keep out of reach of children.
- Always use carrying handle when transporting the Crusader®.
- It is always recommended to bring the VOLT METER with you.

HOW TO SETUP THE CRUSADER™:

- Check oil level!! If oil level is good, please proceed. If oil level is low or empty then please read
 engine manual to determine oil type.
- Pour into gas tank 87 octane or higher grade gasoline (LEAD FREE). DO NOT ADD DIESEL OR OTHER FUEL!!
- When running the CRUSADER on a hard surface place a piece of rubber-backed carpet underneath it to keep it from moving and to maintain slack in the pump/controller cables.

(MANUAL) STARTER (This setup is incorporated into the Crusader™ How to Start the CRUSADER™:

- Turn the fuel shut-off valve one-quarter turn which is the OPEN position.
- Push the choke lever to CHOKE position.
- Move the throttle to FAST. Operate the engine with the throttle in the FAST (rabbit) position
- Grasp rope handle. Pull slowly until resistance is felt, then pull rapidly to start the engine and avoid kickback. WARNING: Keep hands and arms from becoming entangled in the rope as it is being pulled out or rewinding.
- Let the engine warm up. Slowly adjust choke toward RUN position. Wait until engine runs smoothly before each choke adjustment.
- Adjusting the gas throttle to lower the RPM simply move the throttle away from the FAST (rabbit) position (toward the tortoise).
- Remove the red alternator power cable from the red storage connector
- · Connect the red alternator power cable to the red battery power connector
- Now turn "ON" the alternator switch from the "OFF" position to the "ON" position. This will allow
 the alternator to start producing dc voltage around 14.5 volts and max amp output will be
 estimated at 50-55 amps dc.
- Since the Crusader is now running and producing dc voltage please disconnect the red alternator
 power cable from the red battery power connector and insert it into the red storage connector.
 Think of it like this.... Once the Crusader is running it doesn't require the small battery any longer.
 The small battery is to start the Crusader that is all. Make sure the Crusader® alternator is
 outputting at least 14 volts dc. If so then the Alternator is working properly.
- Please, connect the pump or controller to the alternator terminals located on the CRUSADER™, connecting negative alternator terminal to negative pump or controller alligator clamp and connecting positive alternator terminal to positive pump or controller alligator clamp. Now it is time to Sample like a champ!

NOTE: THE ALTERNATOR DOES NOT CHARGE THE BATTERY.

Never reverse polarity Alternator or battery terminals – doing so may damage the battery and/or alternator WARNING: UNIT GETS EXTREMELY HOT PAY ATTENTION TO HOT LOCATIONS!!!

REWIND (MANUAL) STARTER How to Stop the CRUSADER Gas Powered Generator:

- CAUTION: Do not stop the engine by moving choke control to CHOKE. Backfire, fire or engine damage could occur.
- · Move throttle to SLOW, then to STOP.
- Then close fuel shut-off valve.

STORING and TRANSPORTING the CRUSADER™ Gas Powered Generator:

- ALWAYS! Connect the red alternator power cable to the red storage connector!!
- Make sure that the "ON" switch located on the alternator is in the "OFF" position.
- If the CRUSADER is to be stored for extended periods, follow the instructions for storage in the engine manufacturer's manual.
- If it is necessary to store the unit for extended periods with gasoline in it, add a fuel stabilizer. Always keep in a well-ventilated area!!

HOW TO CHARGE THE CRUSADER®:

- Charge Alternator Battery every 30 days. Failure to do so will result in a dead and nonchargeable battery.
- It is acceptable to trickle charge Alternator battery 24 hours a day 7 days a week with the included Vmax 3.3 AMP charger.

MAINENANCE SCHEDULE:

- The engine oil should be changed after the first hour of operation. Then refer to engine manual.
- The coupling between the engine and alternator should be sprayed with a Gunk® silicone lubricant every 10 hours of operation to extend its life.
- Before operating, always visually check the cables for fraying or damaged insulation.
 Repair or replace any defective cables
- Engine oil: see engine manufacturer's recommendations
- There are no user serviceable parts in the alternator. Opening the alternator housing will
 void the warranty

Trouble Shooting:

- If engine fails to start please first check gasoline tank to make sure there is gas present. If
 the Crusader™ has been stored for a long period of time (over 6 months) please make sure
 the alternator battery is at least 12.5 volts. If it still fails to start please make sure the gas
 has not gone bad. In addition, please check oil level to make sure there is adequate oil. If
 the engine still will not start please refer to engine manual.
- If Crusader[™] fails to output voltage on the alternator please check both fuses leading to the battery. If the fuse or fuses are burnt out please replace them with an 80 amp MAXI Fuse.
- If Crusader™ fails to output voltage even after both fuses were replaced please contact the Distributor from whom you purchased the product.
